# Regular Meeting on July 10, 2006

## A-6

Discussion/Action concerning FM 1386 - Judge Wright.

FM 1386 was previously deeded from the State of Texas to Caldwell County. Caldwell County was to take over maintainance of FM 1386 in exchange for the State of Texas purchasing all Caldwell County right of way for the building of State Highway 1888. Judge Wright informed Commissioners Court that the State of Texas will take back FM 1386 and will also take back maintenance of FM 1386 and will also purchase all Caldwell County right of way for State Highway 130. No action needed.

## A-7

Discussion/Action concerning the roof damage at the Scott Annex Building - Joe Roland.

Commissioner Roland informed the Court that Caldwell County will have to wait for insurance payment on damage to the roof at the Scott Annex Building but Leo Miller Roofing will need to go ahead with the repair and replacement coating roof on this building to avoid further damage to the building. No action taken.

#### A-8

Discussion/Action whether to impose extra fees relating to registration of vehicles in Caldwell County - Judge Wright.
