She recommended a \$50.00 rental fee per machine used. Presentation on Regional Transportation Planning – Joe Cantalupo, Exe. Director.

There was lengthy discussion concerning the Capitol Area Metropolitan Planning Organization CAMPO. Joe Cantalupo, Executive Director, presented a request for Caldwell County to join CAMPO. Caldwell County has projects in development in the next year and a half and he suggested that Caldwell County attend and be included in the CAMPO meetings. CAMPO will adopt a 25 year plan in April 2010 and Caldwell County could be voted into (join)CAMPO and be included in that plan at that time. This would accomplish their desire to have a 5 county 25 year plan. There will be more presentation and Mr. Cantalupo will get a complete analysis of Caldwell County projects for future discussion.
