#### A-7

Discussion/Action concerning a roadway variance request for the proposed Spanish Oaks Estates Subdivision from Section 3.3.1, Appendix B of the Caldwell County Subdivision Regulations specifying a minimum right of way width of 50 feet to approximately 26.6 feet — Commissioner Madrigal/Joel Richardson.

The 127 foot road entrance to this subdivision is approximately 26.6 feet wide and variance was requested on this limited right of way. Sheriff Law and Unit Road Administrator Jeffrey expressed concerns about the "bottleneck" that could occur with traffic during an emergency. Other areas of concern such as drainage, stop signs, and turnarounds for safety in this proposed subdivision were discussed. Motion was made by Commissioner Madrigal, seconded by Commissioner Roland, to grant the variance request with the provisions that a turnaround for safety vehicles would be included at the end of the 127 foot 26.6 foot wide entrance roadway, that all safety precautions would be taken at the entrance to this subdivision, and that the subdivision would be built by the guidelines of the flood plane regulations. Motion carried with Commissioner Madrigal, Commissioner Roland, and Judge Wright voting "Aye" and Commissioner Bonn and Commissioner Bullock voting "No." Commissioner Bonn stated he would like to see the area before voting on it. Commissioner Bullock stated he does not see why Commissioners Court should approve this subdivision when the Court doesn't accept others. Judge Wright, in voting yes to break the tie vote, stated that this subdivision is better engineered than most subdivision plans and he has no objection to approving the preliminary plan.

#### **A-8**

Discussion/Action to approve Continuing Education Certicate for 12 hours for Commissioner Tom Bonn – Judge Wright.

Motion made by Judge Wright, seconded by Commissioner Madrigal, to approve the Continuing Education Certificate for 12 hours for Commissioner Tom Bonn. Motion carried unanimously.

#### A-9

Discussion/Action concerning a proposed concept plan for Cherryville Subdivision located on north side of Highway 80 in Caldwell County – Commissioner Madrigal/Don Cherry.

Michael Wilson and Steven Ihnen with Garrett-Ihnen presented the proposed concept plan for Cherryville Subdivision located on the north side of Highway 80 at CR 110 where the proposed State Highway 130 will cross Highway 80. All areas of this concept were presented including housing, schools, hospital, parks, industrial parks, wastewater and water issues. Commissioners Court commented that this appears to be a very professionally done project. This presentation was for information only.

Commissioners Court recessed the Regular meeting to go into Executive Session.

Caldwell County, Texas et al; Cause No. 09-0-282 in the 421<sup>st</sup> District Court of Caldwell County, Texas.

Commissioners Court closed the Executive Session and went back into Regular meeting.
