## A-7

Discussion/Action to award bid for two half-ton pick-ups for the building maintenance and Co. Extension Agent departments – Sonny Rougeou.

Motion made by Commissioner Bonn, seconded by Commissioner Roland, to accept the award of bid of \$20,776 from Caldwell Country for two trucks for the Building Maintenance and County Extension Agent departments. Motion carried unanimously.

#### A-8

Discussion/Action to award bid for one half-ton pick-up for the Sanitation Department – Sonny Rougeou. Motion made by Commissioner Madrigal, seconded by Commissioner Bullock, to award the bid of Caldwell Country for one half-ton pick-up for the Sanitation Department. Motion carried unanimously.

## A-9

Discussion/Action to award bid for three 3/4-ton pick-ups for the Unit Road - Sonny Rougeou.

Motion made by Commissioner Bullock, seconded by Commissioner Bonn, to purchase three crew cab trucks for Unit Road from Caldwell Country. Motion carried unanimously.

#### A-12

Discussion/Action to continue lease agreement with the Caldwell County Fair Association – Judge Wright. Judge Wright stated that the Caldwell County Fair Association now has an attorney. A demand letter was received by Caldwell County wanting to know what Commissioners Court is going to do. The Fair Association wants to know if Caldwell County is going to honor the extension of the lease for twenty five years as the original lease indicates. There was discussion concerning the show barn property that is the subject of the lease agreement. The lease agreement expires 10-29-2009. Judge Wright maintains that the Fair Association should change their rules to reflect that no child in Caldwell County is disqualified from showing their animal in the Caldwell County Junior Livestock Show. It was questioned whether this Commissioners Court can bind a future Commissioners Court for the extended lease. Motion was made by Commissioner Roland, seconded by Commissioner Madrigal, to table this item in lieu of a legal opinion on paragraph 12 concerning Commissioners Court ability to bind a future Court. Motion carried unanimously.

Motion made by Commissioner Roland, seconded by Commissioner Bullock, to approve the proposed 2009/2010 budget of Caldwell County. Motion carried with Commissioner Bullock, Commissioner Madrigal, and Commissioner Roland voting "Aye" and Commissioner Bonn voting "No."

Discussion/Action to adopt proposed tax rate FY 2009-2010 for Caldwell County – Sonny Rougeou. Motion made by Judge Wright, seconded by Commissioner Bullock, to adopt the tax rate of .6910 for the FY2009-2010 for Caldwell County. Motion carried unanimously.
