



## **MARKS & BRANDS RENEWAL**

As per Agriculture Code Chapter 144.041, each person who owns cattle, hogs, sheep or goats shall record that person's earmarks, brands, tattoos, and electronic devices with the County Clerk in which the animals are located.

A person who owns a horse shall record an identification mark authorized by Section 144.001(b) with the County Clerk of the county in which the animal is located.

The effective date of this Application is August 31, 2021 to August 30, 2031  
Renewal of this Brand/Mark must be filed during the period  
August 31, 2031 to February 28, 2032

The Mark/Brand must be re-recorded every ten years.

The current Mark/Brand will expire August 30, 2031.

Renewals may be filed with the Caldwell County Clerk, Monday through Friday from 8:30 am to 5:00 pm, at 1703 S. Colorado St. Lockhart, TX.

The recording fee for a mark or brand is \$25.00 for the first location and \$5.00 for each additional location at the initial filing. Added locations later will be the same fee as a new registration.
