DSHS request wearing a face covering when 6ft distance is not possible. Judge Haden also added that Caldwell County has 6 confirmed cases, and wanted to point out that the only information given by DSHS for these individuals is Gender and Age, after all investigations are complete we will receive the Zip Code of the individual.
