- **2014.01.21.03** Announcements: Items or comments from Court Members or Staff.

  Commissioner Roland said that the Martin Luther King march yesterday was the largest ever. They marched from City Hall to Cedar Hall. A very diverse crowd and a great turnout.
- 2014.01.21.04 Citizens' Comments: At this time any person may speak to Commissioners Court if they have filled out a Caldwell County Commissioners Court Participation Form. Comments will be limited to four (4) minutes per person. No action will be taken on these items and no discussion will be had between the speaker(s) and members of the Court. The Court does retain the right to correct factual inaccuracies made by the speakers. (If longer than 30 minutes, then the balance of comments will continue as the last agenda item of the day).

James Greene spoke on behalf of the First Presbyterian Church in Lockhart. It is has been on the property for many years and has worked well with the neighboring businesses maintaining the parking lot and the shared space around it. He has asked that the County considers them when the property around them is put on the market to be sold. This could hurt the church, should the agreement with the a new owner not continue, as they only own half of the parking spaces. Judge Bonn replied that he could not discuss at this time but it would be taken into consideration.

Curtis Weber updated all present on the progress in Luling at the Precinct 2 offices. The renovation is proceeding as planned with the A. D. A. entrance and the renovation of the interior.

Tax Collection Report December 2013 – Larry Roberson Larry Roberson, Caldwell County Auditor read the Tax Collection report for the month of December 2013.

Accident Report & Updated on Training – Captain Mike Lane Captain Mike Lane reported that so far, eight (8) of the Deputies had been through the Driver Safety course at the San Marcos Police Department. They had favorable feedback and when another class became available, the Sheriff's Office would send more for training.

#### 2014.01.21.08 Special Presentations.

Digital Imaging Project for Caldwell County Clerk – Carol Holcomb, Carol Holcomb, County Clerk presented examples of the books from Deed Records, one that was awaiting preservation and one that had been processed by Cogniserv. Lance Gonzales of Cogniserv explained the process and answered questions that the Court had. County Auditor, Larry Roberson explained that the cost comes from the preservation fund and not from the County Clerks budget.

**2014.01.21.09 Discussion/Action** regarding enactment of Emergency Order Prohibition of Outdoor Burning in Caldwell County.

Emergency Management Coordinator Martin Ritchey spoke to the Court updating the past weeks concerns in the County. He said that he had talked to a few of the Fire Chiefs and they had had expressed the need to leave the burn ban in effect, that Travis and Hays Counties had enacted theirs today. Judge Bonn had enacted the Emergency Order last Wednesday. Motion made by Commissioner Roland, second by Commissioner Muñoz to leave the burn ban on at this time.

- **2014.01.21.10 Discussion/Action** concerning a private entrance to the restroom from Judge's office in Precinct 2 located at 505 Fannin Street, Luling, Texas. **Cost:** None; **Speaker:** Judge Bonn; No Action Taken.
- 2014.01.21.11 Discussion on purchase of 42 Dell Used Laptops in the amount of \$46,438 for the Elections Department. Cost: \$46,438 Mark Hinnenkamp

Mark Hinnenkamp spoke to the Court explaining the process he had taken for estimates to purchase laptops for the elections department. Elections Administrator Pam Ohlendorf spoke to the Court and explained that after calculating, there was a need for 26 additional laptops, she has 14. The use of laptops with E-Poll would minimize chances of voter fraud as well as any mistakes or security during the elections. It would also save the elections employees when transferring data for updating the voting records and data in the registrar's office. County Auditor Larry Roberson explained that the funds for this purchase, if made, would come from Reserves. Judge Bonn said that there would be further discussion on the subject.

**2014.01.21.12 Discussion/Action** regarding insurance claim for county vehicle involved in November 22, 2013 accident.

Explaining that this process is usually taken care of by TAC, County Auditor explained that Dairyland Ins. has offered the County 80% of the fair market value of the 1995 truck that was in the accident. Because of age and condition, it wasn't worth a lot. County Attorney Mack Harrison explained the situation and Motion made by Judge Bonn, second by Commissioner Roland for Mack to reply to the insurance company with the offer of 100% of fair market value and they take possession or for 80% of fair market value and the County would keep the remains of the vehicle. Commissioner Buchholtz updates the Court and the public with the maps describing the location and the area recommended for the County Energy Transportation Reinvestment Zone. Changes to the proposed area will be discussed.

## CALDWELL COUNTY, TEXAS EMERGENCY ORDER PROHIBITION OF OUTDOOR BURNING

WHEREAS, according with the provisions of the Texas Disaster Act of 1975 and the Order of the Caldwell County Commissioners Court dated February 22, 1988, and amended January 26, 2004, a State of Disaster has been declared based on the eminent threat of disaster from wild fires; and

WHEREAS, declaration of such a disaster authorizes the imposition of controls on activities which can increase the likelihood of such fires.

**BE IT THEREFORE ORDERED,** that the following emergency regulations are hereby established for all unincorporated areas of Caldwell County, Texas for the duration of the above mentioned declaration:

#### 1. Action Prohibited:

- (a) A person violates this order if he/she burns any combustible materials outside of an enclosure, which serves to contain all flame and/or sparks, or orders such burning by others
- (b) A person violates this order if he/she engages in any activity outdoors which could allow flames or sparks that could result in a fire, unless done in an enclosure designed to protect the spread of fire, or orders such activities by others.

#### 2. Enforcement:

- (a) Upon notification of suspected out-door burning the fire department assigned shall respond to the scene and take immediate measures to contain or extinguish the fire.
- (b) As soon as possible, the Caldwell County Fire Marshall's Office shall be notified and sent to the scene to investigate the nature of the fire.
- (c) If, in the opinion of the officer investigating and the Fire Chief, the goal of this order can be obtained by informing the responsible party about the prohibitions established by this order the officer may at his discretion notify the party about the provisions of this order and request compliance with it. In such instance a report shall be made containing the date, time, and place of the warning along with the name of the party receiving the warning and forwarded to the office of the Caldwell County Fire Marshall.
- (d) At the discretion of the Caldwell County Fire Marshall and/or the Fire Chief, or Incident Commander a violation of this order may be prosecuted.

**BE IT ALSO ORDERED,** that this Order may be enforced by any duly commissioned peace officer and violation of this order may be prosecuted as a *Class* "C" Misdemeanor punishable by a fine not to exceed \$500.00.

**BE IT ALSO ORDERED,** that the purpose of this order is the mitigation of the hazard posed by wild fire during the term of the dry, weather by curtailing outdoor burning; which purpose is to be taken into account in any enforcement action based upon this order.



### **Engineering Geology Studies**

investigate naturally occurring soils and rock. In adverse construction environments, geologic survey information becomes vital for the design of soil improvement methods. Geologic literature, including materials include geologic maps, geotechnical reports, engineering plans, environmental reports, stereoscopic aerial photographs, remote sensing data, GPS data, topographic maps, and satellite imagery, is typically reviewed during a study. Our fieldwork culminates in an engineering geologic report providing our client an organized reference for geologic findings, data analysis, and recommendations.



### Forensic Studies

The success of a project often depends upon understanding why and how it failed. Since tomorrow's projects will be even more technically sophisticated, Raba-Kistner develops forensic studies that serve clients' short- and long-term objectives for performance, efficiency, and cost-containment.

Our forensic engineers combine geotechnical expertise with emerging technology to develop causations and remedial measures for a variety of issues. Studies range from distressed foundations to retaining walls and slopes, failed pavements, and roads. Accidental discharges of water including sewer leaks, pool leaks, and drainage failures are also examined. As methods of soil improvement can be costly and time-consuming, an evaluation of soil movement induced damage (e.g., caused by trees) offers

remediation options for foundation design or retrofit.

Raba-Kistner has specialized equipment and sampling devices that can obtain soil samples in areas with limited access. Our in-house versatile instrumentation capabilities allow us to test distressed materials, evaluate the cause(s) of distress, and develop remedial measures. For four decades, our professionals have conducted many forensic investigations projects and have provided expert witnesses testimony for our clients.

### Geotechnical Design Studies

A project's successful performance during and after construction is our number one objective. Raba-Kistner's geotechnical design studies meet this objective for a diversity of projects.

Clients use Raba-Kistner's services to assess soil/rock foundations for residential, commercial, and industrial buildings. Studies also direct foundation decisions for tanks, towers, cranes, dams, docks, and bulkheads. Clients receive a preliminary site reconnaissance and an evaluation of the project's feasibility and/or master planning. Recommendations are then developed for foundation design and construction.

The performance of sloped or braced excavations and trenches rely on geotechnical design studies. Projects may include wooden shoring, trench boxes, tiebacks, soldier piers, and diaphragm walls. Our studies evaluate lateral pressures and bearing capacities. As part of dewatering system design, our geotechnical design studies assist construction and protection of permanent structures. An evaluation often recommends well points and French drains using mineral or synthetic materials. Design



studies of retaining walls and cutoff walls requires a critical evaluation of lateral pressures, bearing capacities, and drainage. The design and construction of concrete and earthen dams, embankments, and excavation slopes are based on engineering studies. Raba-Kistner develops project criteria using computer-aided design analyses.

Geotechnical design studies often provide clients with general pavement guidelines. Raba-Kistner's broad experience with similar conditions and soil classification and testing supports the quality of our studies. Comprehensive pavement design studies for parking lots, roadways, and airfields require more complex on-site and laboratory testing techniques. Our team fulfills these project requirements using California Bearing Ratio, TxDOT Triaxial, and Dynaflect methods. Geotechnical engineering evaluations are conducted for siting, design, and construction of numerous water and waste retention/disposal projects. Clients' objectives range from man-made ponds for retaining water to industrial and municipal effluents and percolating rainfall runoff. After construction, settlement and cracks in foundations and structures may occur for numerous reasons. Underpinning and/or shoring may be required to allow for remedial excavation or other construction. Specialized foundation support and excavation techniques may be required to protect existing structures and to avoid expensive repairs. The alternatives engineered by our geotechnical specialists have provided savings to our clients.

### **TxDOT Studies**

Design and construction of functional transportation structures requires an indepth understanding of the interaction of soil, rock, and groundwater conditions. Precertified in the practices and standards required by TxDOT, Raba-Kistner has partnered with them for 40 years on a wide variety of geotechnical engineering studies. Systematically collecting and analyzing basic to complex geotechnical data, Raba-Kistner has participated in all phases of TxDOT




project success. In South Texas alone, we have contributed to more than 10,000 public and private sector geotechnical studies. In conjunction with most studies, we have carried field and laboratory testing programs for bridge foundations, retaining walls, roadways/highways, and signage/light standards. Field procedures, boring spacing, and depth requirements as established by TxDOT's Geotechnical Manual, August 2006 are rigorously followed.

Whether working with the Texas Turnpike Authority, regional mobility authority, regional toll authority, or through private-sector developers, Raba-Kistner is capable of fulfilling the requirements of accelerated delivery. We participate in exclusive development agreements (EDAs) and comprehensive development agreements (CDAs) as an alternative means of supporting needed road and bridge construction. Engineering safe, efficient, and cost-effective transportation solutions continues to be our priority.



### **ENVIRONMENTAL CONSULTING**

Responding to environmental issues with sound science, regulatory compliance, and common sense, Raba-Kistner provides a strong interface between client, community, and regulator.

Raba-Kistner offers services that balance regulatory and public health and safety issues with our clients' goals and objectives. We develop the scope of environmental project activities and prepare necessary regulatory reports. Our solutions draw from the coordinated effort of a multidisciplinary team supported by in-house research and testing capabilities and a commitment to our clients' best interests.

The diversity and difficulty of environmental assignments completed by Raba-Kistner are extensive. From environmental site assessments (ESAs) to clarify corporate real estate transactions, permitting municipal solid waste facilities throughout the Southwest, Gulf Coast wetland delineations to infrastructure crossing environmental projects improving the U.S.-Mexico border, and asbestos abatement programs for educational campus renovations to archaeological and cultural resource investigations for major transportation corridors, Raba-Kistner's completed project record demonstrates an ability to meet our clients' needs while proactively identifying key issues, recommending practical options, and achieving regulatory compliance.



### <u>Archaeology / Cultural Resource</u> <u>Management</u>

Raba-Kistner strives to reconcile the objectives of planning and development projects with the concern for preserving historically significant properties. As stipulated by Section 106 of the National Historic Preservation Act (NHPA), all federally-licensed or funded projects must account for the effect of their activities on historical/cultural resources.

Other types of projects may call for archaeological investigations under state and local counterpart regulations. In Texas, state agencies and political subdivisions must notify the Texas Historic Commission (THC) of any action on public land. Typically required by THC, an archaeological survey of the proposed impact area evaluates the presence and significance of archaeological sites.

Raba-Kistner assists a diversity of public and private clients whose projects are prescribed by the NHPA, state, and/or local directive. Our cultural resource management implements Phase I surveys and historical



and archival research. Phase II testing is supplemented by standing structure surveys. Compliance-related investigations routinely necessitate execution of Phase III mitigation and site treatment, consultation, and oversight. Services are supported by industry standard equipment and methods. We are well-versed in geophysical prospecting techniques, Geographic Information Systems (GIS), and Global Positions System (GPS) survey applications.

A majority of our projects require a National Environmental Policy Act (NEPA) environmental assessment (EA), environmental impact statement (EIS), or a state-level equivalent. Coordination of cultural resource compliance is usually required. In these instances, Raba-Kistner's services seamlessly include the cultural resource investigation and report along with the preparation of NEPA documentation.



### Geosciences

### Environmental Compliance Consulting/ Risk Analysis

Clients are often challenged by the environmental rules and regulations applicable to their industry. Part of our geosciences expertise focuses on keeping abreast of the Texas Risk Reduction Program and Petroleum Storage Tank (PST) rules, the myriad of related laws and regulations, and their revisions and interpretations. Minimizing our clients' liability in complex environmental compliance situations sets us apart from other consultants.

### Geologic Assessments/Karst Feature Surveys

Our geologic assessments (GAs) and/or mapping services are necessary prior to property development over designated areas including the Edwards Aquifer Recharge Zone. A survey of karst features is also usually required to rule out habitat likely to support endangered karst invertebrate species. Based on the assessment of potential habitats and hazards, Raba-Kistner's results are reported as part of our clients' land use application and Water Pollution Abatement Plans (WPAP). Within the project boundaries, GAs identify:

- Sensitive recharge features (faults, fractures, caves and sinkholes, solution cavities, and non-karst closed depressions)
- Karstification of limestone terrain, and manmade features (utility trenches and water wells)

### Aggregate Reserves Studies

Our investigations and studies of aggregate reserves for property transactions target active/potential quarry sitings and evaluate quarry reserves. A preliminary review of published and site-specific geological data is routinely made. Geophysical exploration, exploratory drilling, trenching, and collection of aggregate samples follow. Results from our in-house materials testing and geoscience analysis then become keys to recovering the quantity and quality of aggregate required by our clients.

Petroleum Storage Tank Investigations Investigative experience in PST issues and knowledge of applicable regulations is critical to assisting our clients with PST compliance. Partnering with our clients, we develop realistic strategies for spill prevention control and countermeasure



plans. From convenience gas stations to airports and municipal services, our geoscientists address a variety of needs such as:

- Tank site characterizations
- PST closures
- Operating compliance investigations

### Contamination Assessments

Raba-Kistner's geoscientists develop site characterizations and contamination assessments for a diversity of objectives including:

- Hazardous waste and industrial facilities
- Petroleum storage tanks
- Municipal solid waste sites

In light of applicable regulations, we review site specific and analytical data and interpret the compliance status of operations. A practical, cost-effective, and environmentally-compliant strategy can then be developed for our clients.

### Geophysical Surveys and Geologic Mapping

Geophysical survey and geologic mapping inform clients about naturally occurring and manmade variations in sub-surface conditions beyond the reach of direct core sampling. Raba-Kistner continually applies innovative technologies to scientific and engineering challenges. We add value to projects by characterizing subsurface conditions without incurring more costly, time-consuming, destructive procedures. Our in-house remote sensing technologies are effective in:

- Identifying and mapping subsurface features and anomalies
- Characterizing aquifers

- Identifying and mapping fault and karst features
- Evaluating dam integrity
- Delineating contaminant pathways
- Analyzing aggregate reserves



### Groundwater/Hydrogeologic Investigations

As a result of increasing demand on our water supplies, development and protection of groundwater resources has become a serious concern for many clients. Raba-Kistner's engineers and scientists apply extensive field and analytical data gathering techniques to evaluate and characterize groundwater conditions. We meet our clients' objectives by determining location, quality, aquifer producing capacity, transport of contaminants, and contamination remediation.

### **Natural Resource Consulting**

Clients choose Raba-Kistner when a project is anticipated to impact natural resources. Our goal is always to provide the necessary natural resource protections while maintaining the project's economic feasibility. We assemble a team of biologists, ecologists, environmental scientists, technicians, and engineers to meet our clients' most challenging resource concerns.



Raba-Kistner's services undertake wetland and Waters of the U.S. determinations and delineations. We specialize in preparing Section 404/401 Individual and Nationwide permits as well as in developing and implementing wetland mitigation plans.

Private companies, individuals, and public agencies must all comply with the Endangered Species Act (ESA). This act prohibits the "taking" of federal and statelisted species. To avoid the costly consequences of noncompliance, our natural resource team evaluates proposed construction sites for their impact on threatened or endangered species.

For projects with federal funding or where a federal permit is required, a Biological Assessment is typically required. Other regulations, including the International Migratory Bird Treaty Act, are weighed in the evaluation. If the site's impact to sensitive habitats is unavoidable, we provide a mitigation plan outlining conservation measures to minimize this impact.

### **Environmental Planning Consulting**

Raba-Kistner's environmental professionals are specialists in preparing Environmental Planning documentation required by NEPA. We understand the importance of public involvement and complete and open disclosure of findings. We are versed in producing EISs, EAs, and categorical exclusion (CE) documents consistent with federal and state laws and agency regulations and procedures. Our team's combined practice of more than 40 years demonstrates a successful record of NEPA-compliant documents.

Environmental Planning services have been major federal actions considered likely to have a significant effect on the environment. Raba-Kistner has established working relationships with several agencies including:

### **Environmental Permitting**

Environmental permitting, licensing, and compliance service is required in an ever-increasing number of public and private sectors. Our in-depth understanding of local, state, EPA, FERC, and related federal requirements allows us to guide clients through the regulatory process. Raba-Kistner's engineers prepare plans for applications from surface and ground water protection to site development and operations.

Our services also cover wetlands and endangered species, wildlife, fisheries, recreation and land use/management planning, and archaeological programs. We have conducted siting, licensing, and permitting for small and large solid/hazardous waste facilities and expedited



landmark emergency response action plans. Our team of engineers and scientists will represent clients at public hearings and meetings and explain and defend the permit application's technical aspects, as needed.

Lead-Based Paint and Asbestos Surveys, Plans and Abatement Monitoring, O&M Programs

Raba-Kistner's team of engineers, certified inspectors, and technicians address leadbased paint and asbestos health hazards and related legal issues. Clients include school districts, building owners, architectural/engineering firms, development contractors, lending and insurance institutions, and various public agencies.

Our management services typically begin with pre-abatement consulting, sampling, and analysis. If lead-based paint or asbestoscontaining materials are recommended for removal, monitoring of abatement operations, sampling, and analysis follow. Postabatement consulting and reporting services confirm compliance with abatement plans and specifications and applicable EPA and OSHA guidelines and regulations. In cases where minimal lead-based paint or asbestoscontaining materials exist and can be controlled, Raba-Kistner designs and assists implementation of an operations and maintenance (O&M) program. The program is monitored by periodic inspections, and our reports make recommendations for future control.

Environmental Site Assessments
ESAs are typically conducted prior to
property transfer or financing. Our engineers
are experienced in the design,
implementation, and management of site
investigations and remedial technologies.
Phase I ESAs include an investigation and

review of selected documents to establish the environmental status of the site. If evidence of contamination is found, Phase II ESA services develop and implement sampling and analysis of environmental media or wastes. The Phase II ESAs answer our clients' questions as to the extent and level of contamination and estimate the cost of remedial action. Environmental remediation activities are performed during Phase III ESAs.

Property owners and managers, insurers, and prospective investors are positioned with options for directing funds to maintain and improve the value of their asset or to safely shut it down.

Our Facilities Engineering team addresses the asset as a whole while targeting clients' concerns. A Property Condition Assessment (PCA) can be conducted as part of a real estate transaction and due diligence process. Damage assessment and remediation scope development often prove invaluable following an emergency. Building code, occupancy, and regulatory compliance review and recommendation are typical necessities fulfilled by Raba-Kistner. Maintenance evaluation and development of information management programs can assist short and long-term budgeting.

Because roof systems are one of the most expensive and replaceable elements of a facility, Raba-Kistner has assembled a team of roofing specialists. Our licensed architects, LEED APs, structural and civil engineers, and registered roofing designers partner with clients to provide comprehensive, innovative consulting and testing services. From preventative maintenance to roof replacement, these specialists have served a diversity of projects including schools, hospitals, hotels, multi-family residential housing developments and condominiums, shopping centers, and high-rise offices.



### Construction and Contract Administration

Whether a facility is scheduled for new construction, repair, or restoration, clients rely on Raba-Kistner to oversee their project's contract compliance. Contract administration by a technically competent, experienced facilities engineer or architect is requisite to construction efficiency and economy. We complete our client's project team by establishing and executing appropriate, objective checkpoints to compare the work's progress and quality with the contract's schedule and construction requirements.

At the heart of every successful project is the ability to bring people and resources together to achieve a common goal. Prior to the start of construction, a Raba-Kistner representative meets with the owner and his contractor or



their representatives. The pre-construction meeting establishes protocols for communication, required documentation, processes for submitting construction documents, applications for payment, and related procedures impacting the project's contract administration.

During construction, our representative visits the site to observe the work and its conformance with the contract. Raba-Kistner's site observations determine whether to accept, reject, or modify the contractor's periodic applications for payment. If change orders are required, we can assist the owner in negotiating the scope with the contractor and coordinate their execution with the owner. Raba-Kistner can review submittals due from the contractor including as-built drawings, specified materials, and equipment warranties. This documentation is assembled and presented as a project closeout item.

Comprehensive contract administration requires an in-depth understanding of facility design and construction specifications, applicable building standards, and regulations. Clients also expect and deserve systems-in-place or protocols for monitoring construction methods, change orders, defective materials, schedule changes, and acceptable payment processes.

Raba-Kistner's construction loan monitoring services are tailored to the level of a project's complexity and the construction phase at which we enter. Raba-Kistner typically performs initial document review, escrow draw review, periodic site visits, and progress reporting. Costly delays, those that disrupt scheduled construction loan draws, are anticipated and minimized or avoided, and

the interests of lenders, developers, state and local agencies are protected.



### MATERIALS RESEARCH & RECYCLING

Recycling asphalt, brick, and concrete can be profitable for project contractors and developers. Just how economically attractive this decision can be is often determined by Raba-Kistner's CoMET services.

Raba-Kistner offers clients specialized testing and consulting solutions for recycling. Our capabilities include the evaluation of materials reuse and feasibility analysis of recycling from construction and demolition (C&D) projects. Recycling mitigates the ecological impact of these activities. Its advantages include logistical efficiency for construction activities. Recycling can also reduce demolition, loading and hauling costs, and landfill fees and can be less expensive than purchasing and importing virgin materials.

Raba-Kistner's laboratory researches alternative uses of materials proposed for demolition. For example, our team of senior materials consultants and engineers can develop mix designs that incorporate the recovered materials to meet TxDOT standards and local government regulations. Recommendations are also made in accordance with guidelines for handling of solid waste. Daily quality assurance testing conducted by our team is typically requested to document that products produced conform to project specifications.

Trained and certified in a range of procedures, our technicians conduct many field and laboratory customized tests upon request. Our labs' AASHTO and A2LA accreditations confirm that our facilities meet rigorous standards for testing and analysis procedures and equipment calibration.



### Testing and Recycling Capabilities

The nature of Raba-Kistner's work allows us the vantage point of cutting edge technology and building methodology. Keeping pace with the expansion demands of the Southwest, we research and evaluate the feasibility of incorporating recycled materials into construction projects and offer testing of the material's performance and durability.

Major projects typically require high volumes of Portland cement concrete. Our materials specialists design and test all types of concrete to meet the needs of our clients' projects. We design dense low permeability concrete as well as porous free draining concrete. For flowable backfill, we design and test both high and low strength concrete. Aggregates, cement, fly ash and admixtures can also be tested for certification and conformity. 

#### **ARTICLE I**

#### MEETINGS OF THE COMMISSIONERS COURT

- 1.00 All Regular, Special, Emergency and Executive Session Meetings of the Caldwell County Commissioners Court will be called and conducted in accordance with the provisions of the Texas Open Meetings Act. Chapter 551, Texas Government Code.
- 1.01 The Open Meeting Act, codified as Chapter 551 of the Texas Government Code, provides that all Regular, Special and Emergency Meetings of the Caldwell County Commissioners Court are open to the public and to representatives of the press and media. Executive Sessions of the Commissioners Court are not open to the public, the press, or the media. Executive Sessions only allows for those individuals expressly requested or ordered to be present.

#### Regular Meetings

1.02 The Caldwell County Commissioners Court meets in Regular Session at 9:00 a.m. on the second, third, and fourth Mondays of each month. The Commissioners Court may change the day of the week for meetings once each year. [See §81.005 (a) of the Local Government Code where in the Court by Order sets the day of the week the Court will meet at the last regular meeting of the Court each fiscal year]

#### Special Meetings

1.03 A Special meeting of the Commissioners Court may be held at any time called for by the Court or by the County Judge. Either the County Judge or three (3) Commissioners acting together may call a Special meeting of the Commissioners Court. (§81.005 (b), Local Government Code.)

#### Regular Meeting Places

1.04 At the first regular term of each calendar year, the Commissioners Court may select, on no less than seven (7) days' notice, a new site at which the Court's terms are to be held that year subject to §81.005 (d) of the Local Government Code.

1.05 Special meeting locations may be held at venues different from where the Regular meetings of the Court are held.

# IN THE COMMISSIONERS COURT OF CALDWELL COUNTY

ORDER AUTHORIZING THE CREATION OF A COUNTY ENERGY TRANSPORTATION REINVESTMENT ZONE KNOWN AS

# CALDWELL COUNTY ENERGY TRANSPORTATION REINVESTMENT ZONE NO. 1

ESTABLISHING A BASE YEAR FOR AD VALOREM TAX VALUES, CREATING AND STATING THE TERMS AND DUTIES OF THE CALDWELL COUNTY ENERGY TRANSPORTATION REINVESTMENT ZONE ADVISORY BOARD, AND ESTABLISHING AN AD VALOREM INCREMENT ACCOUNT

BE IT REMEMBERED, that the Commissioners Court of Caldwell County, Texas, prior to this date, has provided public notice by publication in a newspaper of general circulation in the county to be printed not less than seven (7) days prior to a public hearing, and after conducting said public hearing as required by §222.1071 of the Texas Transportation Code on the 9th day of December, 2013, the Commissioners Court of Caldwell County, Texas does hereby:

- 1. Make a formal determination that Caldwell County has been severely affected by the development of new oil and gas activity within the county generally, and more particularly, adversely affected by the increased heavy truck traffic on county maintained roads, and
- 2. Further determine that Caldwell County would benefit from the availability of funds provided by the State of Texas pursuant to the provisions of Chapter 256 of the Texas Transportation Code, and
- 3. The area described more fully herein is unproductive and underdeveloped and the creation of a County Energy Transportation Reinvestment Zone would promote the public safety, facilitate the improvement, development or redevelopment of the property affected and enhance the County's ability to sponsor transportation projects within the county funded by said zone.

4. Finally, the creation of a County Energy Transportation Reinvestment Zone and the establishment of an ad valorem tax increment account will assist the county in addressing the fiscal needs of the county, while permitting enhanced stability in the county budgeting process.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Commissioners Court of Caldwell County, Texas, hereby establishes and creates a County Energy Reinvestment Zone as authorized by Chapter 222 of the Texas Transportation Code, such Zone to be titled as Caldwell County Energy Transportation Zone No. 1 and operated in compliance with said Chapter, and the Commissioners Court further designates the contiguous territory identified in Exhibit A, attached hereto and incorporated herein by this reference, as the zone in which the captured appraised value of real property located within the zone shall be used to determine the tax increment funds to be devoted to transportation infrastructure projects within the limits of said county.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the base year for purposes of determining the subsequent tax increment for the Caldwell County Energy Transportation Reinvestment Zone No. 1 shall be the year of 2014, being the year of adoption of this Order, on the 21 day of January, 2014

In this regard, it is the FURTHER ORDER OF THIS COMMISSIONERS COURT, that an Advisory Board for the Caldwell County Energy Transportation Reinvestment Zone No. 1, is hereby created, whose members shall serve for two years terms, and whose successors may be appointed by the Commissioners Court as their terms expire, or as vacancies may occur from time to time. The Advisory Board for the Caldwell County Energy Transportation Reinvestment Zone No. 1, shall not be entitled to receive compensation for service on the board, nor entitled to reimbursement for expenses incurred in performing services as a member of the Advisory Board. The Advisory Board shall meet not less than quarterly, in compliance with the Texas Open Meetings Act, and shall perform such tasks, or functions as provided by law and as the Commissioners Court may from time to time require of the Advisory Board. The Advisory Board shall review all project plans for the zone created by this Order, and shall provide comment and recommendations to the Commissioners Court regarding the development of all plans and expenditure of funds from the Tax Increment Account established to benefit Transportation Infrastructure Projects within the county funded by the zone created by this

Order. Such recommendations shall be duly considered by the Commissioners Court, but are not binding upon the Commissioners Court.



IT IS FURTHER ORDRED, ADJUDGED AND DECREED that the County Treasurer shall establish a suitable interest bearing account, to be known as the Caldwell County Energy Transportation Reinvestment Zone No. 1 Tax Increment Account, and that such funds as may be accrued, pursuant to the provisions of §222.1701, Texas Transportation Code, shall be deposited annually into said account, together with such other and sundry funds as may be allocated to the said tax increment account by the Commissioners Court of Caldwell County, Texas. Such funds may only be expended in compliance with Section 222.1071 (i) and (j), of the Texas Transportation Code, and only by separate Order of the Commissioners Court.

The Caldwell County Energy Transportation Reinvestment Zone No. 1 shall remain in full force and effect for the initial term of ten years from the date of formation, and shall terminate on January 21 of the tenth (10<sup>th</sup>) year after designation of the zone, unless terminated earlier in conformity with law.

On Nov. 21, 2013, by minute order No. 113766, the Texas Transportation Commission adopted rules, codified as Title 43 Texas Administrative Code §§15.180 – 15.197, that prescribe the policies and procedures governing TxDOT's implementation of the county transportation infrastructure fund grant program under Transportation Code, Chapter 256, Subchapter C. Pursuant to the program, TxDOT will administer a grant program using the transportation infrastructure fund and provide funding to eligible counties for transportation infrastructure projects located in areas of the state affected by increased oil and gas production.

On Nov. 21, 2013, by minute order No. 113773, the Texas Transportation Commission specified the first period of time in fiscal year 2014 for submission of grant applications for the program, and the total amount of grant money available for the designated period.

#### Lone Star Local Technical Assistance Program (LTAP)

This program will provide limited technical assistance for the development of project cost estimates to counties that request it. The LTAP program plans to offer workshops in several locations around the state during January 2014 and will be available for one-on-one follow-up.
