Call Meeting to Order.

2015.03.23.01

Invocation. Lockhart Ministry Alliance.

John Griffin with The Bread of Life Church opened the meeting with prayer.

2015.03.23.02

Pledge of Allegiance to the Flags. (Texas Pledge: Honor the Texas Flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible). Judge Schawe led all present in the Pledge to both Flags.

2015.03.23.03

Announcements. Items or comments from Court Members or Staff. Commissioner Muñoz said that he had attended the Cesar Chavez March the past weekend. He said that it was a good turnout.

2015.03.23.04

Citizens' Comments. At this time any person may speak to Commissioners Court if they have filled out a Caldwell County Commissioners Court Participation Form. Comments will be limited to four (4) minutes per person. No action will be taken on these items and no discussion will be had between the speaker(s) and members of the Court. The Court does retain the right to correct factual inaccuracies made by the speakers. (If longer than 30 minutes, then the balance of comments will continue as the last agenda item of the day).

- 1. **Claudia Brown** said that she lives across the street from the proposed landfill site. She is pleased that the Court will be a party at the Contested Case Hearing. Representing the County is the foremost position.
- 2. **Kyle Bishop** lives directly across the street. He is a pastor in the area. He thanks the Court for doing the right thing. It's sometimes costly and not always easy. He thanked them for seeking party status.
- 3. Kathleen Clough said that the Court did something bold when the Court made the decision to take part in the Contested case hearing. She said that fear of what it may cost has become a concern. She explained that there is no cost at this first step. There are multiple options available later on for any new decisions.
- 4. **Jodie Friedrich** said taking part in the contested case hearing for the 130 landfill will be the biggest thing for our County. The County must have a voice. She said that she had a packet with over 800 signatures opposing the landfill and asked the Commissioners to stand up for the County residents.
- 5. **Byron Friedrich** encouraged the members of the Court to attend the contested case hearing. He explained the procedure and asked the Court to represent the County with the facts.
- 6. **Frank L. Sughrue** gave the Court a packet of information. He said that there was no cost to seek party status and requested that the Court put together a plan for our County.

- 7. Fermin Islas said that he is hopeful that the Judge has changed his vote concerning seeking party status. He congratulated the Commissioners for standing up for the citizens and the County. He spoke about the concerns for economic values, protecting the water supply and possible leaking. He said that after spending \$10.8 million for the new Justice Center, he feels that fighting the landfill would be money well spent for our County. He hopes that Judge Schawe will change his vote.
- 8. **Ronald L. Forest** told everyone about the Job Fair that will be held at the Compassion Center in Luling on April 1st. He gave a brief overview of the Compassion Center and shared concerns for unemployment situations in Caldwell County.
- Alfred Cano said that he was a member of the silent majority. He feels
 that representatives are listening to a small group. That it is going to cost
 the County money. He asks them to get out of the small circle and hear
 the majority of the County.
- 10. Robert Kohler explains that the County does not have to retain legal counsel for the contested hearing. He stated that it is not necessary to hire outside council. The County attorneys can represent if needed. There is plenty of time to think about outside representation.
- 11. **Leslie Holder** said that since the announcement of the proposed landfill, a group of vigilant citizens have researched all the dangers. She spoke about legacy, duty and conscience. She asked the Court to keep the meanings in the forefront while in Executive Session.
- 12. **Deborah Bissonnet** said that the proposed landfill will be a nuisance and a problem for our County not just for years or decades. It will impact generations to come.
- 13. Lou Mac Naughton spoke about the impact that the proposed landfill would have on our County. Environmental, financial and the dangers of additional traffic are just the beginning. The effects would be for generations.
- 14. **Marisa Perales** said that she was not in favor of reconsideration by the Court. She explained the process that Guadalupe County has decided to approach the issue. She explains that there is no cost to the process in the first steps.
- 15. **Linda Pittman** said that last week, the Court made her proud to be a Caldwell County citizen. The image of having left a legacy can be favorable. She asked the Court not to be the one that left a legacy of a landfill.
- 16. **Kathy Haigler** spoke against 2015.03.23.10 to re-consider requesting party status in the contested case hearing regarding 130 Environmental Park, SOAH Docket No. 582-15-2082; TCEQ Docket No.2015-0069-MSW and related matters. She does not want her tax dollars to be used for a lawsuit. She said that every single minute does cost the county. She asks the Court to be smart and not get involved in the lawsuit.
- 17. **Jessica Neyman** expressed appreciation to agreeing to seek party status. She spoke about "Roberts Rules of Order" and the legality of the posting. She thanked the Court for serving the County.
- Alicia Thornton read a letter written by a landowner that has changed his mind for an investment property in Caldwell County. The owners name was Javier Fuentez.

Michael Aulick explained to the Court that $2/3^{rd}$ of his fee should be reimbursed by TXDOT when the jobs are finished and as long as the regulations are followed.

Motion made by Commissioner Muñoz, second by Commissioner Madrigal to extend Michael Aulick's consultant contract for six months, not to exceed \$30,000. All Voting "Aye"

All Voting "Aye" The Commissioners all agreed that Larry had been a great asset to the County and thanked him for all of his work.
