Discussion to consider entering into an Interlocal Agreement with the Central Texas Dispute Resolution Center for the purpose of mediating of court cases. **Speaker:** Commissioner Munoz; **Cost:** None; **Backup:** 13.

Jason Irle, executive director of the Central Texas Dispute Resolution Center explained the organization and the importance of mediation services within the court system. 421st District Court Judge, Judge Blomerth agreed that mediation services are a great asset to the courts. Jason Irle specified the fee as \$15 per civil case for use of mediation services. Judge Schawe requested more information including the approximate amount of fees that would be collected annually for this service in Caldwell County. Commissioner Madrigal and Commissioner Roland expressed the importance of having a mediation service available in our court system.

Discussion/Action regarding an ongoing audit by the State Comptroller. **Speaker:** Judge Schawe/Debra French; **Cost:** TBD; **Backup:** None.

County auditor, Debra French explained the current status of the ongoing audit by the State Comptroller's office. The audit is being conducted on the District Clerk's office, County Clerk's office and the Justice of the Peace offices. She said the audit should be completed in October of this year and that the county may owe money to the state estimated at \$350,000. She said the offices use codes that assess which fees should be payable to the state and said they may not have been designated properly to ensure the state was receiving their funds. County Treasurer, Lori Rangel discussed the process of remitting fees in her office. District Clerk, Tina Freeman explained how she operates the coding system and reports in her office. Commissioner Muñoz shared concern for the different software programs used. Lori Rangel suggested elected officials contact their individual software companies to make sure the fees and codes are correct. The auditor's office is looking over the codes and fee schedule to correct the matter.

Chief Juvenile Probation Officer, Jay Monkerud said the Caldwell County Juvenile Board is requesting \$501,465.00 in local funding for Fiscal Year 2017. He said that would be an increase of \$17,774.00 or 3.7% from last year.

Discussion/Action to approve the request for funding by the Information Technology Department to extend the warranties of the EqualLogic's Storage Area Network devices. **Speaker:** Judge Schawe/Mark Hinnenkamp; **Cost:** \$4,520.91; **Backup:** 4.

IT Director, Mark Hinnenkamp stated there is a failing piece of equipment that is critical for information storage that is not under warranty. He explained the company will fix the issue if the warranty is purchased and will remain under warranty for one year. The new piece of equipment costs \$1,300.00.

Motion made by Commissioner Muñoz, second by Commissioner Moses to approve the IT Department to extend the warranties of the EqualLogic's Storage area network devices. All voting "Aye".
