Section 521.242 - Eligibility

- (a) A person is eligible to apply for an occupational driver's license if:
 - (1) the person's license has been suspended, revoked, or canceled for a cause other than:
 - (A) a physical or mental disability or impairment; or
 - **(B)** a determination by the department under Section 521.294 that the person is incapable of safely operating a motor vehicle;
- (2) the person does not hold a driver's license and is ineligible to obtain a driver's license because of a suspension order, including an order due to a conviction or an order under Chapter 524 (Administrative suspension of driver's license for Failure to Pass Test for Intoxication) or Chapter 724 (Suspension of driver's license for refusal to submit to the taking of a specimen); or
- (3) the person is ineligible to obtain a driver's license because the person holds a driver's license issued by another state or country that was suspended, revoked, or canceled for a cause other than a physical or mental disability or impairment.
- **(b)** An occupational driver's license does not authorize a person to operate a commercial motor vehicle to which Chapter 522 applies.
- (c) A petition filed under this section must set forth in detail the person's essential need.
- (d) A petition filed under Subsection (b) must state that the petitioner was convicted in that court for an offense under the laws of this state.
- (e) The clerk of the court shall file the petition as in any other matter.
- **(f)** A court may not grant an occupational license for the operation of a commercial motor vehicle to which Chapter 522 applies.
