Discussion/Action on a Resolution authorizing the preparation and submission of a 2011/2012 (PY) Texas Community Development Block Grant (TXCDBG) Application to the Texas Department of Rural Affairs (TDRA) for funding under the Texas Community Development Block Grant Program (TXCDBG) - Judge Duesterheft/Philip Ruiz.

It was explained that this same type of Resolution was approved for the McMahan Water Supply Corporation grant and also the Maxwell Water Supply Corporation grant. Motion made by Commissioner Madrigal, seconded by Commissioner Cyrier, to approve the Resolution authorizing the preparation and submission of a 2011/2012 (PY) Texas Community Development Block Grant (TXCDBG) Application to the Texas Department of Rural Affairs (TDRA) for funding under the Texas Community Development Block Grant Program (TXCDBG). Motion carried unanimously.

Discussion/Action to accept the Bid on seized manufactured home described as a 14 X 80 mobile home label number TEX 0076169 and being generally located at Scott Trailer Park. State Park Road, Lockhart Texas (tax id. No. 41397) - Judge Duestereheft/Attorney Steve Bird.

Steve Bird, attorney representing the tax suits at the Caldwell County Central Appraisal District, requested Commissioners Court accept the bid on a seized manufactured home that was seized, auctioned with no bids, and now the adjacent property owner submitted this bid to buy the home. Motion was made by Commissioner Madrigal, seconded by Commissioner Bullock, to approve the bid on the seized manufactured home described as a 14 X 80 mobile home label number TEX 0076169 and being generally located at Scott Trailer Park, State Park Road, Lockhart Texas (tax id no. 41397). The bid is for \$800.00. During discussion, former Commissioner Tom Bonn questioned whether the sale of the manufactured home was on a parcel of property that may not have enough room for complying with the Caldwell County septic regulations. Mr. Bird stated that moving the home was not in the bid and the home may be in a condition that it cannot be moved. Motion carried unanimously,

Discussion/Action regarding an Interlocal Agreement between Caldwell County and City of Neiderwald concerning maintenance of a portion of Schuelke Road - Commissioner Madrigal. Commissioner Madrigal explained the the City of Niederwald requested Caldwell County maintain a small portion of Schuelke Road and the City of Niederwald will reimburse Caldwell County. Caldwell County has an Interlocal Agreement with the City of Martindale for road maintenance. Motion made by Commissioner Madrigal, seconded by Commissioner Bullock, to approve that a Resolution be on the Commissioners Court agenda next week for an Interlocal Agreement between Caldwell County and the City of Niederwald concerning maintenance of a portion of Schuelke Road. Motion carried unanimously.

Discussion/Action regarding a request for support and financial contribution for the continued success of the Community Health Coalition of Caldwell County for the FY 2011 - Judge Duesterheft/Cynthia Barrera. Cynthia Barrera requested assistance with the Patient Pharmacy Assistance Program that helps approximately 300 patients, some Indigent Health Care patients, in Caldwell County. Motion made by Commissioner Roland, seconded by Commissioner Cyrier, to approve \$15,000 for next years budget for the support and financial contribution for the continued success of the Community Health Coalition of Caldwell County for the FY 2011. Motion carried unanimously.

It was reported that the fiber optics lines put in by Time Warner move data too slow and a solution to figure out what to do to move the data faster needs to be addressed. Also, all phone systems are analog systems. DFW's proposal is to address these issues for Caldwell County. Commissioner Cyrier explained that the County is in great financial shape and this would be a good time to address these issues along with issues in item A-12. Motion made by Commissioner Cyrier, seconded by Commissioner Roland, to move forward and approve the proposal by DFW Technology Professional Services to evaluate, diagnose and isolate causes for degrade backup performance at a cost of \$5050 and to assess the County's aging phone system with a Unified Communications Solution, (Planning Phase Complete) at a cost of \$1,885. Motion carried unanimously.
