Consideration and approval of a resolution by the Commissioners Court of Caldwell County, Texas approving and authorizing publication of notice of intention to issue of one or more series of certificates of obligation; complying with the requirements contained in securities and exchange commission rule 15c2-12 and resolving other matters in connection therewith – Judge Duesterheft.

Jennifer Douglas with Specialized Public Finance presented information concerning the issuance of certificates of obligation and different options for Caldwell County. A decision needed to be made to be able to advertise the notice if issuance was desired on December 20, 2010. Motion was made by Commissioner Cyrier, seconded by Commissioner Madrigal, to adopt and approve the Resolution by the Commissioners Court of Caldwell, Texas approving and authorizing publication of notice of intention to issue of one or more series of certificates of obligation for an amount not to exceed 1.5 million to cover costs of project management and repairs to the Caldwell County Courthouse and the Caldwell County Judicial Center. Motion carried unanimously.

#### A-5

Discussion/Action regarding a request for a variance to sell approximately 9.8 +/- acres out of 10.854 acres to the adjoining land owner Mr. Perryman – Commissioner Bullock.

Commissioner Bullock and surveying company representative Linda Hinkle explained that Ms. Bennett is a widow who presently owns this 10.854 acres and she desires to deed all but one acre to adjoining property owners, the Whittingtons and Perrymans, who will get a right of first refusal to also purchase the one acre kept by Ms. Bennett. Motion made by Commissioner Bullock, seconded by Commissioner Roland, to issue a variance to allow Ms. Bennett to sell approximately 9.8 acres out of her 10.854 acres to the adjoining land owners. Motion carried unanimously.
