Tri Community Water Supply Corporation President Howard Berg wanted to mention that on the April 12, 2010 Commissioners Court agenda Tri Community Water Supply Corporation was called Tri County Water Supply Corporation.

Bastrop area TxDOT representative Johnny Eddleton stated that the large tree on the northeast side of the Courthouse Square will need trimming. Motion made by Commissioner Madrigal, seconded by Commissioner Roland, to approve the Texas County & District Retirement System (TCDRS) benefit plan for Caldwell County employees. Motion carried unanimously.

#### A-7

Discussion/Action concerning Tri-Community Water Supply Corporation, inadvertently referred to as Tri-County Water Supply Corporation, request that Caldwell County apply on behalf of Tri-Community Water Supply Corporation for TX-CBDG funds to assist in the installation of a filtration system mandated by TCEQ – Commissioner Roland (Continued from the April 12, 2010 meeting)

There was an error in the April 12, 2010 agenda item that referred to Tri-Community Water Supply Corporation as Tri-County Water Supply Corporation. Motion was made by Commissioner Madrigal, seconded by Commissioner Cyrier, to support Tri Community Water Supply Corporation in their effort to obtain a grant for the installation of a new filtration system. It was again mentioned that Tri Community Water Supply Corporation has been cited by TCEQ for both their wells to be corrected. They will ask for an extended deadline to correct the wells due to the time needed for application and funding of this grant. Motion carried unanimously.

#### A-12

Discussion/Action to approve Resolution No. 04-2010 asking TXDOT to save Historic Oak Tree on the north side along proposed route of SH 130 in Caldwell County — Commissioner Cyrier.

Commissioner Cyrier stated there was hope that the contractor could find a way to save the historic oak tree on the south side of the SH 130 construction but the costs for a change order to save the tree was close to \$487,000. However, the tree on the north side of the construction will be saved and a letter from Carlos Lopez of TXDOT will state that any dollars saved after this change order will be used for overpasses and feeder and tie roads in Caldwell County. Commissioner Cyrier read the Resolution. Motion made by Commissioner Cyrier, seconded by Commissioner Bullock, to approve the Resolution No. 04-2010 asking TXDO to save Historic Oak Tree on the north side along proposed route of SH 130 in Caldwell County. Motion carried unanimously.
