Call to order.

The meeting was called to order at 9:00 A.M.

A-1

Approve Minutes of Previous Meeting.

Motion made by Commissioner Roland, seconded by Commissioner Madrigal, to approve the minutes of the Regular meeting on July 19, 2010. Motion carried unanimously.

A-2

Citizens' Comment: (At This Time Any Person With Business Before the Commissioners Court, Not Scheduled On The Agenda, May Speak To The Commissioners Court. Comments Will Be Limited to Three (3) To Five (5) Minutes Per Person.

Judge Duesterheft started the meeting with a moment of silence in memory of Caldwell County employee Rachel Anzaluda and her son who passed away last week.

Discussion/Action concerning joint project with Guadalupe County to replace the bridge located on 240B, Scull Crossing Bridge - Commissioner Madrigal-Commissioner Cesareo Guadarrama, Guadalupe County. Judge Duesterheft introduced Guadalupe County Commissioner Cesareo Guadarrama and also introduced Larry Timmerman who has been approved by Guadalupe County to construct the bridge at Scull Crossing whenever Caldwell County approves the Scull Crossing bridge replacement. Judge Duesterheft stated that emergency vehicles hesitate to use the Scull Crossing bridge because of its deteriorating condition. The history of the bridge replacement at Scull Crossing was explained. TxDot had the bridge replacement on their agenda but at the time there was a disagreement about the bank to bank placement of the bridge. Commissioner Guadarrama explained that Guadalupe County represented the Sculls property rights concerning the bridge replacement at the time. Guadalupe County was in agreement with the placement of the bridge ½ mile down the river and problems developed on the Caldwell County property owners side and the bridge replacement plans fell apart again. The TxDot grant monies for the Scull Crossing bridge replacement were lost. Commissioner Guadarrama stated that Guadalupe County is seeing tremendous growth on their side of the river with future subdivision development. He explained that Guadalupe County Commissioners Court has already approved the Scull Crossing bridge replacement. It was explained that Caldwell County owns the Scull Crossing bridge and Guadalupe County maintains and repairs the bridge. Martindale Mayor Loraine Harrison stated she only heard about this meeting from friends. Commissioner Madrigal explained he talks to someone at the City of Martindale weekly and was sorry she was unaware of todays meeting. This item has already been placed on the Martindale council agenda. Larry Timmerman explained the proposed bridge replacement that will take approximately two months to build. The concensus of Caldwell Commissioners Court is that this will be a very good project but Caldwell County Commissioners will first meet with the City of Martindale for their approval of the bridge replacement and the road construction to the bridge. Motion made by Commissioner Roland, seconded by Commissioner Bullock, to leave the Outdoor Burning Ban off for Caldwell County. Motion carried unanimously.

Discussion/Action regarding a request from the Democratic Party Chair to hold an early voting polling place at Gary Job Corps located in San Marcos for the November 2, 2010 Election – Commissioner Madrigal. Commissioner Madrigal stated he wanted to clarify that the Democratic Party Chair did not request this item for consideration and that there was a call and letter from Gary Job Corp. Fred Bucholze stated that he feels if Caldwell County wants to expand the early voting for its residents, it should set up early voting in Martindale or McMahan or have later hours at the two present early voting places. Election Administrator Vicky Gonzales stated she has not received any required petitions for early voting and if she did receive a petition it would have to be precleared through the Justice Department. The two early voting places that are normally available to the voters in Lockhart and Luling are already in place for the November election. Alfonso Campos stated he feels the voters at Gary are not accessible to the candidates because he cannot enter Gary Job Corps to talk to the voters. Loraine Harrison stated that Gary Job Corps is federal property and Caldwell County should not be accommodating the voters there. Candidate Mark George stated if Caldwell County does for one it should do for all and this would be opening up a can of worms. Resident Carol Peters mentioned that not all voters at Gary Job Corps are transient voters. Kathy Bliss stated the nature of the voting location at Gary Job Corps is such that no one else can go there to vote which over the years has been a great concern. J.P Judge DeLeon stated he is for expanding early voting to other areas. Howard Berg stated he sees the Gary Job Corps personnel in buses and they could be bused out into the community to vote. Democratic Party Chair Philip Ruiz stated it is regrettable that Caldwell County has only two early voting locations and wishes early voting could be extended to local grocery stores. Election Administrator Vicky Gonzales stated she would have to hire additional election personnel if a petition for additional early voting is received by her office. Motion made by Commissioner Cyrier, seconded by Commissioner Madrigal, to table this item. Motion carried unanimously.
