Call Meeting to order.

1. Pledge of Allegiance to the Flags. (Texas Pledge: Honor the Texas flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible).

Judge Bonn led the court in the Pledge for both flags, United States and Texas.

2. 9:00 Public Hearing concerning adoption of the tax rate for 2011-2012 fiscal year.

Public Hearing began at 9:02 a.m. Ron Heggemeier asked that if the citizens spoke if they would please give their name and address. Rick Johnson spoke concerning the 2011-2012 proposed budget. Tracy Forrester comments that she has heard there will be tax raises. Barbara Decker questions how there will be more tax revenue that is in the proposed budget if the tax rate is going down.

- 4 Reconvene Commissioners Court Meeting. 9:13 a.m.
- 5. Citizen's comments: at this time any person with business before the Commissioners Court, not scheduled on the agenda, may speak to the Commissioners Court. Comments will be limited to three (3) to (5) minutes per person.

Commissioner Cyrier assists Danney Rodgers, Delhi Volunteer Fire Department Chief, and Chuck Cutshall, McMahan Volunteer Fire Department Chief, with a slide show of the Delhi fire. This fire started September 3, 2011 and is still smoldering. At this time, they report that Caldwell County has lost over 6000 acres, 16 homes and 15 barns and out-buildings. They are not able to begin to figure out a loss of livestock. Chuck Cutshall recognizes Danney Rodgers for his excellent job in handling the situation and his continuing effort with little sleep and other conditions. As of this time, there were no injuries or loss of lives. They are concerned and speak to Commissioner's Court about the inadequate emergency communication system and that they had to use their own cell phones to communicate at times. They thank Gonzales for the use of their command center and the "800" radio systems. (These are the equipment style, not a numerical amount).

Chuck Cutshall speaks about the Volunteer Fire budget and asks the public if they can to please make donations to the Volunteer Fire Dpts. There are many repairs and many of the firefighters have been using their own vacation time to continue on the scene. Bernadette Cutshall informs public about the fund raisers and events that the area departments have to raise money for their areas and asks more citizens to attend if possible. Lena Sustala from McMahan thanked the Lockhart residents for being generous and giving donation this past weekend at the Wal-Mart in Lockhart.

Tracy Forrester expresses feelings of Caldwell County employee's pay scale and feels more could be done. Susan Modrall speaks about grants, Non Governmental Organizations and the possible loss of land owner's rights.

6. Approve Minutes of Previous Meeting (August 29th, 2011)

Motion made by Commissioner Cyrier, seconded by Commissioner Buchholtz to approve the minutes from August 29, with two changes. (1) Addition of Dental Select as a purchase option to item # 7, and (2) correct item # 17 to reflect Commissioner Roland voted "No", all others voted "Yes". Agreement to approve minutes, All voting "Aye". MOTION PASSED

7. Discussion/Action concerning recommendation of contractor for the Historical Caldwell County Jail of 1909-Judge Bonn/Coyle Buhler PE.

Coyle Buhler recognized the members of the Historical Commission that were present. He explained background information concerning the grant and the status of the project at this time. There are three steps to be taken today. Motion made by Commissioner Cyrier, seconded by Commissioner Buchholtz to reject the bid from 5J"s Construction, of Lexington, Texas on the Historic Caldwell County Jail project because a required bid guarantee in the form of a Bid Bond or Cashier's check for 5% of the bidder's total bid was not received, and the Caldwell County requests approval from TXDOT for the bid rejection. All voting "Aye". MOTION PASSED

Motion made by Commissioner Cyrier, seconded by Commissioner Buchholtz to authorize Judge Bonn to request approval from TXDOT and negotiate and execute a contract with the lowest qualified bidder, Tolero Construction, for \$136,500 plus the \$18,600.00 for alternate equaling \$155,100.00 subject to a budget amendment approved in Commissioners Court. All voting "Aye". MOTION PASSED

Motion made by Commissioner Cyrier, seconded by Judge Bonn to go to TXDOT and request additional funds. All voting "Aye". MOTION PASSED

Jeff Kuhn and Jennifer Douglas explained the incentives, interest rates and the restrictions that are attached to use the 2010 Certificates of Obligation. They verified the funds could be used for repairs of any facility that has been owned by the County since December 2010 but not purchase of equipment.

The panel is made of three citizens and the following elected officials, the sheriff, county tax assessor-collector, county treasurer, county clerk, district clerk, criminal district attorney.
