Staff Recommendations: County Administrator recommends acceptance of the low bid of Floors Plus in the amount of \$18,467.00 for the Scott Annex flooring and the low bid of \$16,000.00 from Aptiva for the Market Street Annex flooring.

Staff Recommendations: Both the County Administrator and County Auditor recommend changing the reserve requirement to a two-month requirement following a cash flow analysis from this past tax year's collections in the October thru December period.

10.08.21 Discussion/Action concerning setting a restricted reserve amount of \$740,000.00 for employee retirement and allowing the Caldwell County Investment Committee to invest said reserve pursuant to County investment policy. The \$740,000.00 amount to be restricted out of the existing general fund reserve. Cost: None, but does place a restriction of the use of \$740,000.00 of current general fund reserve amounts; Speaker: Ron Heggemeier/Larry Roberson; Backup: 1.

Staff Recommendations: Both the County Administrator and County Auditor recommend setting a restricted reserve for employee retirement in order to fund the current unfunded actuarial accrued liability for the Caldwell County Retirement plan for calendar year 2012. This set aside of the reserve amount will ensure that the retirement plan is funded 100% for end of year 2012.
