Judge Bonn was pleased to see the attendance at the Memorial Day Celebration and thanked the 4-H and AgriLife Groups that helped in the preparation and serving of the reception. There were 105 plates served.

05.29.13 Discussion concerning the installation of speed cushions on Meadow Lane (County Road 69) near Martindale.

Commissioner Madrigal discussed the past weekend with the opening of the new tubing business in the area. He informs the Court of the speed and safety problems that were faced by the neighborhood. The Commissioners and Judge Bonn discuss the property ETJ and the cost to the County. County Engineer, Bill Gardner recommends that the County accept no money from the business owner for the cost of the speed cushions. Commissioner Roland is not in favor of the County having to pay for the cost of speed cushions. Judge Bonn is concerned with the safety of the residents if the drivers begin to cut into the yards to avoid the speed cushions. There is no action at this time.

05.29.14 Discussion/Action concerning the Caldwell County development ordinance – omission of Property-line Adjustment.

Section 3.3.1 (A) of the Caldwell County Development Ordinance (<u>Requirements for Exempted Subdivisions</u>) is hereby modified to add the following:

7) a conveyance of property that results in an adjustment or change in boundaries between two adjacent unplatted tracts, provided the number of tracts, number of owners, and total area of the tracts affected remains unchanged after the conveyance, and provided each tract consists of more than one (1) acre in area after the conveyance.

Motion made by Commissioner Madrigal, seconded by Commissioner Buchholtz to adopt the rewording provided, to the Caldwell County Development Ordinance.
