They all do the same jobs, to take care of people and save lives. Neal Kelley discusses the growth and participation that the Seton network has already invested in Caldwell County and the programs for further advancements. Glen Germer explains that there were a lot of the same anxieties and questions when Seton came to Luling in 1999, and things smoothed over. He says that CCMAT is very important to the community. They are the first responders and have the same common interest, to take care of the patients. Citizens were given opportunity to make comments and ask questions to the panel. Speaking to the Court were Chuck Cutshall, Carol Ohlendorf, Mike Hendricks, Susan Modrall, Kathy Sellers and Linda Hinkle. Concerns and questions were asked by Aaron Langford and two of the Lockhart EMS employees. Sam Huenergardt said CTMC would like to be considered for a collaborative program. Recognition of 3 of the members of the Lockhart City Council and John Castillo said that he would like to have more information on the program. No Action Taken.
