- 09.10.09 Discussion/Action concerning Texas State Tubes' request for a temporary variance (from September 10, 2012 until October 25, 2012) to the Caldwell County Rules for On Site Sewage Facilities regarding portable toilets.
  County Engineer Bill Gardner spoke to Court Members recommending the temporary variance for Texas State Tubes. Rocco Moses said that the facilities should be done in the spring. Judge Bonn informed Mr. Moses that the Court would frown if this was requested again. Motion made by Commissioner Madrigal, second by Commissioner Roland to approve a variance to allow temporary use for September 10, 2012 –October 25, 2012 for portable toilets on the Texas
- **O9.10.10 Discussion** concerning the abandonment of alleys and roads in Caldwell County. Commissioner Buchholtz said that he didn't see it as giving away an asset, more as a liability if they need to be maintained. Commissioner Madrigal agrees and sees it as an added tax that could be collected by giving it back to the owner. Commissioner Roland speaks in agreement. Matthew Allen, CCAD, spoke about the alleys and "streets" in the County that are not developed or maintained.
- 09.10.11 Discussion concerning a needs assessment on the potential savings of \$250,000.00 in the 2012-2013 Budget.
  Judge Bonn makes note that the amount is now \$264,000.00 due to the 3% raise that the City gave. Commissioner Buchholtz would like to see a needs assessment on the potential savings of \$250,000.00 in the 2012-2013 Budget. He would like to see it be used on the County Roads. Commissioner Roland comments that is too early to start talking about it.
