The Court does retain the right to correct factual inaccuracies made by the speakers. (If longer than 30 minutes, then the balance of comments will continue as the last agenda item of the day).

Those signed up for comments:

- 1. Dee Rodgers said that she would like for the Commissioners to put their differences aside and do what is best for our county.
- 2. Susan Stewart feels that Caldwell County doesn't need a Human Resource Dpt. or a County Administrator.
- 3. Ray Chandler said that the county is changing and the Human Resource Dpt. It is necessary to protect the rights of our employees and our County. It ensures checks and balances.
- 4. Howard Berg feels that all members of the Court should be prepared for each meeting and not look to the people in the room for decisions. He would like to see the negativity stopped.
- 5. Troy Swift urged the Court to keep the H. R. Dpt. He spoke about the legal side of their job and to consider the employees of our County. The loss of this department leaves our employees vulnerable.
- 6. Tracy Forester believes that the H. R. Department should be abolished. She would like to see small government remain and does not like the way the tax dollars are being spent.
- 7. John Cyrier thanks the Court for the time to speak. He believes that some of the Commissioners are under political pressure to abolish the positions. He spoke about the plans for our Counties growth and asked Commissioner Munoz to do the right thing for our community.
- 8. Stuart Carter concerned about the way that the taxes are going to be spent. He stated that by saving the County in negotiations of the health care contract he believes Ron Heggemeier has already payed for his salary. He said he believed that smaller government is how much money you put in, not how many employees that you have.
- 9. Robert Wilson Pct. 3, questions an agriculture change about fencing requirements and wanted to know who to ask about sheep and goat fencing requirements.

- 10. Steven Zunker Pct. 2, is concerned about the creating of new departments and the turn down of police vehicles and repair of our County roads. He wants the money used to protect our County and new vehicles and equipment for the County Deputy's.
- 11. Kathy Haigler asks who will do the work of the two offices that are being discussed. She asked the Commissioners if they would be taking on the work that is done in Human Resource and the County Administrators office, if it was abolished.
- 12. Kathy McCormick spoke about some of the past changes in Lockhart and that change can be for the good. People just don't like change. She said that the Human Resource Department is important to help employees to move forward.
- 13. Hays County Judge Bert Cobb spoke to Court and said that "Austin has Caldwell County in their bullseye". The growth is coming this way. He stressed the importance of the Human Resource Department. He spoke about the plan for our County and encouraged to pay the employees what they are worth.
- 14. Kathy Sellers said that the County bought the Wal-Mart building without consideration from the tax payers. She wants the two departments abolished because she feels they are a waste of money.
- 15. Susan Modrall has concerns that our County is being compared with larger counties and said that we do not need an H. R. Department.
- 16. George Sanchez asked where the tax money is being spent. He is concerned with the taxes going up and wants to see the Law Enforcement paid more.
- 17. There was also a letter received via-email from Architect, Robert Steinbomer which was read by Commissioner Muñoz in support of the County Administrator. He wrote not only as a business owner but also as a Caldwell County citizen.
