District Clerk Tina Morgan spoke and asked why the amount on the sheet to be posted is different from her budget figures. She feels that she is being penalized for last year's grievance. County Clerk Carol Holcomb also feels that she is being penalized for the grieving process. Commissioner Madrigal feels that the 3 individuals that grieved last year are being penalized this year. Judge Bonn explains that it was like an advance from the five year plan. Judge Bonn calls last years total an advance, 20% a year is the plan. Commissioner Madrigal asks about the Commissioner Court voting on the Elected County Official Salaries before publishing, County Attorney Mack Harrison says there is no need. Commissioner Muñoz says that if the Commissioners don't take their raise then there will be funds when the budget is discussed in Court. Commissioner Roland also agrees with Commissioner Madrigal. He feels that it's unfair not to give the three elected that grieved last year the 20% this year. He also feels they are being penalized.

**06.10.15 Discussion** concerning who will reimburse Caldwell County for expenses incurred by Caldwell County, in the May 28, 2013 abolishment of the County Administrator Department.

Commissioner Buchholtz discusses the process of removing the County Administrator will be a costly expense. His concerns are that he doesn't feel that the taxpayers should be taking on the burden. He refers to the Democrat Party or the no growth group. His objective would be to continue to share with the public what this is going to cost. The administrator was going to be the Project Manager for the Wal-Mart building and we'll probably have to hire someone to do that. It's just getting started but he will let the public know as we find out what the costs are. Commissioner Roland adds that it didn't just start now, it started way back when he (County Administrator) was hired. Don't put the blame in the end. Judge Bonn reminds that the budget was approved.
