Call Meeting to order.
All Court members present

- 2013.10.14.01 Invocation. Caldwell County Christian Ministries.

 Randy Frye, First Christian Church opened the meeting in prayer.
- 2013.10.14.02 Pledge of Allegiance to the Flags. (Texas Pledge: Honor the Texas flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible).

 Judge Bonn led everyone in the Pledge to both Flags.
- 2013.10.14.03 Announcements: Items or comments from Court Members or Staff.

 Judge Bonn said that question of enforcement had been clarified for the weight restrictions and that the constables authorized by Commissioners Court able to enforce the weight limits, could on the County Roads and a Sheriff's Deputy can enforce it on State Roads, and that they could possibly work together. Chief Deputy David Brent conveyed that at this time, the Caldwell County Sheriff Department does not have the manpower for working with the weights.
- 2013.10.14.04 Citizens' Comments: At this time any person may speak to Commissioners Court if they have filled out a Caldwell County Commissioners Court Participation Form. Comments will be limited to four (4) minutes per person. No action will be taken on these items and no discussion will be had between the speaker(s) and members of the Court. The Court does retain the right to correct factual inaccuracies made by the speakers. (If longer than 30 minutes, then the balance of comments will continue as the last agenda item of the day).

 Ann Smith spoke to the court members concerning the 1350 feet of her property that was taken while building the corner of CR 217 and SH 130. She will be leaving her phone number for the Judge to look into this for her.

Kaylon Robinson spoke against the proposed 130 Environmental Park. She asks the Commissioners not to sign a host agreement with Green Group Holdings, LLC due to the uphill location. The unstable soil located at the proposed site which is Post Oak Savannah and Blackland Prairie transitional zone. The runoff will have an effect on Lockhart and Caldwell County residents for many generations.

Deborah Bissonnet spoke to the court with concerns that the 130 Environmental Park could have on the environment, the aquifer and the livestock downstream and locally of the Lockhart area. She also states that the first exposure of Caldwell County will be the landfill. She is very concerned with the effects that it may have on the health and welfare of the community, wildlife and the future generations.

Sarah Hoover with the Clean Air Task Force of Central Texas spoke to the Court concerning the air quality and thanks the Commissioners Court for working with the Task Force.

2013.10.14.09 Update on Estimated Costs of Construction for the future Judicial Center.

Kenton Heinze with Braun & Butler gave the Court members a revised handout of costs for the project. He recognized and thanked the Maintenance team for working so well with his office and doing a great job on the demolition at the future Judicial Center. It has saved the County \$121,000.00 worth of demolition costs. Commissioner Munoz also thanked the Sheriff for working with the team to provide inmate labor. He said that there were still ways that they could successfully save more on the costs to the County. He answered questions from the Court concerning the next step for the project and explained how he would like to handle the step for bids to begin construction.

2013.10.14.10 Discussion/Action to terminate current contract and obtain provider for consulting services for data center to be located in the new Judicial Center.

Mark Hinnenkamp IT Director and Robert Steinbomer explained the frustration of the lack of communication and answers from Angel Mena for the Data Center. It will begin to cost the County money if the flow of communication is not started. Motion made by Commissioner Munoz to have Mack Harrison send a demand letter to Angel Mena that gives a week to respond and produce the documents required or he will be terminated from project. Friendly amendment from Judge Bonn was accepted for the letter to be dated and set out today October 14, 2013. All Voting "Aye"

Discussion/Action concerning the implementation of the 8-Hour Ozone Flex Plan, as part of the clean region's Ozone Advance Program Action Plan under Clean Air- Coalition.

Bill Gill gave a brief overview of the Action Plan and then answered some of the questions from the court. Motion made by Commissioner Buchholtz, second by Commissioner Roland to approve the implementation of the 8-Hour Ozone Flex Plan, as part of the clean region's Ozone Advance Program Action Plan under the Clean Air-Coalition. All Voting "Aye"

Hearing began 10:30 a.m.

Public Hearing 9:45 A.M. on naming the portions of the northbound and southbound State Highway 130 frontage roads that extend about 3,300 feet from the Lockhart city limits to Boggy Creek Road/Fentress Road.

Matthew Allen, Caldwell County Appraisal District explained the process when the City of Lockhart adopted the name. He spoke about the continuity of road names for not only the residents that used the addresses, but the emergency entities that are affected when called. Judge Bonn said that if not for H. T. Wright, Caldwell County would have had to pay for the right of way. He should be honored by naming it after him. Commissioner Madrigal mentioned to possibly name the new Judicial Center after H. T. Wright. Ann Smith, a property owner in this area spoke to the court with concerns about emergency situations.

Public Hearing ends: 10:48 a.m.

2013.10.14.13 Discussion/Action regarding changing the name of the 3,300 feet of frontage road of SH 130 from Old Fentress Road to South Cesar Chavez Parkway. The City of Lockhart adopted the change by ordinance No. 2012-04 (March 2012) to officially name the SH 130 frontage road to be named Cesar Chavez Parkway, this change affected 4 properties owners.

Motion made by Commissioner Muñoz, second by Commissioner Madrigal to name the 3300 feet of both the northbound and the southbound of frontage road of SH130 naming it continuously Cesar Chavez Parkway. Judge Bonn offers a friendly amendment for "H. T. Wright to be the name for the "Northbound direction of the South side of the highway, stating that will have no effect on residents. Commissioner Muñoz does not accept. Commissioner Roland does not think that there should be any possibility for confusion. Roll Vote: Commissioner Muñoz-Yes, Commissioner Buchholtz-Yes, Commissioner Madrigal-Yes, Commissioner Roland-Yes, Judge Bonn-No. Motion Passed

Commissioner Madrigal would like to have former Commissioner Cyrier remain as representative with CAMPO. He said the County has been represented well. Judge Bonn reminds the Court that the County should be represented with an elected official that will be accountable to the public. Motion made by Commissioner Madrigal, second by Commissioner Muñoz to rescind Judge Bonn from the CAMPO Board and to appoint ex Commissioner John Cyrier as our council representativefrom today going forward to the end of December 2014, with request of Commissioner Muñoz as alternate.
