Call Meeting to order.

Judge Bonn asked all citizens protesting to maintain order while speaking. No clapping or chanting. All will have a chance to speak.

 Judge Bonn led all present in the Pledge to both Flags.
- Announcements: Items or comments from Court Members or Staff.

 Martin Ritchey gave an update on the past and present conditions in the County that were caused by the weather. He reported totals over \$394,000.00 and that reports of damages are still being reported. There will be more FEMA teams in the County this week to continue evaluation and tours. He reported details about the fire on this past Friday morning, explaining how the Volunteer Fire Departments had worked together. He cautioned citizens to be careful when using heating devices during the extreme cold temperatures.

John Cyrier introduced Jim Shaw to speak for the Capital Area Housing Finance Corporation. He answered questions from the Court members and was positive that Caldwell County would be included in their plans for building in the future. When Jim Shaw was finished John Cyrier updated all on the status of CAMPO events and funds that Caldwell County would have to help with repairs and growth of the County. He answered questions from the Court.

Curtis Weber, Maintenance Supervisor, spoke about all of the repairs on the County Tax Office.

Curtis Weber reported that the painting on the windows was finished.

Accident Report

Dwight Jeffery Unit Road Supervisor, informed the Court that the County employee was not at fault. Larry Roberson County Auditor said that the other drivers insurance had been in contact. The County vehicle was a total loss.

Public Hearing began: 9:53 a.m.

2013.12.09.15 PUBLIC HEARING at 9:45 AM: Proposed Ordinance Prohibiting Solid Waste Disposal in Caldwell County. Any interested citizen of the county may testify at the hearing.

Alicia Thornton explained that the negative impact that the landfill would bring has already happened. She read an e-mail from Alecia Crowell explaining the decision to move her home and business to Caldwell County. She had decided against when she heard the news of the landfill. She passed out some information on ground water quality to the court members. Patton King said that his family has had roots in Caldwell County since 1800's. His property is on FM 179. There are 4 generations enjoying the land at this time They enjoy the property for the family gatherings as well and he is concerned with the flooding into his well and the tank on the property. His brother intends to retire there as well. He spoke about the noise pollution as well as traffic and air pollution that it will cause.

Jimmy Bertram said that this will impact generations to come and thanks the court for working on the ordinance.

Cynthia Rivera is concerned with the preservation of the beauty of Lockhart and believes that the beauty and the quality of living will be greatly affected with the landfill at the entrance of Caldwell County.

Jessica Neyman speaks about the quality of life with the creation of the landfill. She said that the ordinance will be a stepping stone for economic impact for our County. She is concerned that with the growth of our County the cost of providing for new schools will be burdened upon the homeowners without new business and the landfill will discourage new business to the area.

Leslie Holder said that she moved to Caldwell County to retire. She is concerned with the property values and the safety of citizens in the area with the added traffic on the roads surrounding.

Lou MacNaughton reported that she had done extensive research and is concerned because there are three aquifers in the area proposed. The Carrizo – Wilcox, the Trinity and the Queen City. These provide water to Caldwell County. The waterways all lead to the San Marcos River. Not only the drinking water for citizens but the livestock and agriculture is at risk.

Leslie Banks thanks Commissioners for the work and the leadership in this issue. She is concerned about the many aspects that this landfill can hurt in our County. She feels that it will be a terrible directional marker to lead people into our County.

Fermin Islas feels that the proposed landfill will not only be detrimental to the growth of Caldwell County but to the growth of Lockhart as well. Without economic growth to our County, the tax burden will be on the homeowners. This site being on 183 South, it will be at the gateway to the County.

Frank Sugrue is in favor of the proposed ordinance and is fighting for the soul and health of our County.

Sue Hemphill spoke as an engineer and stated that it will only be a matter of time before the liner on the landfill leaks and she is concerned with the aquifer below. This provides water to the entire county and our drinking water will be contaminated. She supports the ordinance

James Abshier chairman of EPICC spoke in support of the proposed ordinance.

Eva Dechene is in favor of the proposed ordinance. She stated that although her family has only been here about 10 years, She feels that it would be a negative impact on the health and the economic growth of our County.

Belinda Rivera has concerns about the contamination of water supplies. She would like to continue to live in the family home. Several family members have been lost to cancers. She is in support of the ordinance for the generations to come.

Jodie Friedrich has had family in Caldwell County for over 45 years. Study shows that the aquifer provides water throughout the County and this will not be positive economic growth. She also speaks about the fault line and is concerned with geological safety concerning the site on the proposed landfill site.

Robin Schneider with Texas Campaign for the Environment, stated that there is not a need for a landfill in Caldwell County. She told that at this time there are 40 out of 100 landfills in Texas that are leaking. Texas does not have a double liner law. She refers to the Court as the Guardians of the County and urges to support the proposed ordinance.

Kara Savvas shared concerns as a mother and stated that "trash is forever". She urges Commissioners to choose what is good for our County.

Susan Stewart stated that although she's probably lives the furthest from the site of the proposed landfill, she has concerns about the flow of the aquifer and the damage to the water for human, livestock and agriculture.

O. J. Wade spoke about the positive effects of an incinerator.

Jesse Bertram spoke about the generations having owned their land and that no one buys property to live by a landfill. He asks the Commissioners to take it to heart and support the proposed ordinance.

Frank Sanchez said that his family has been here since the 1800's. He is concerned about the noise pollution as well as the water. The increased traffic will lead to safety problems for the County and the health hazards have to be considered.
