- 4. Caldwell County in the amount of \$\\$80.000.00\$, for the County ISDs according to a pro-rata share; Lockhart ISD \$62,000.00, Luling ISD \$14,500.00, and Prairie Lea ISD \$3,500.00, for educational priorities.
