Judge Haden called the meeting to order at 11:30 a.m.

Ezzy Chan, Executive Assistant, announced that the next Commissioners Court will be held on September 23, with the agenda cut off set for Thursday, September 11th.

Mary Eisenberg, a Lockhart resident, expressed concern regarding the data center built six miles from downtown and for future ones planned for the county. She provided information on data centers' water and energy usage, questioned their long-term impact on residents and businesses, and stated that it is time for an open public discussion.

Chet Robbins, member of American Legion Post 177, provided information on *Wreaths Across America*, a volunteer-based organization that coordinates wreath-laying events and offers free programs for veterans and

their families. He announced that a wreath-laying event will be held at the Luling City Cemetery on Saturday, December 13, at 11:00 a.m. Wreaths may be purchased for \$17.00, and additional information was included in the handouts provided.

Andrew McClish, a Prairie Lea resident, spoke about the all-way stop in Prairie Lea and provided background on how it was established.

Anna Nunez, Public Information Officer for the U.S. Small Business Administration's Office of Disaster Recovery and Resilience, stated that Caldwell County is eligible for Economic Injury Disaster Loans for small businesses and nonprofit organizations. The application deadline is April 6, 2026. Handouts were provided to the Court.
