Dear Judge Haden and Honorable Members of the Commissioners' Court,

Pursuant to the recent notice of elected official salaries for Fiscal Year 2026, I am resubmitting this formal response within the five-day period as allowed by statute, in order to respectfully express a grievance regarding my current salary and to request an adjustment based on new and expanded responsibilities.

I am writing to formally submit a grievance regarding my current salary and to respectfully request a compensation adjustment based on newly assigned responsibilities of Accounts Payable department.

As you are aware, I will be assuming full responsibility for the Accounts Payable (AP) department. At present, this function is managed by a single individual; however, beginning next year, I anticipate the need to bring in another part-time or full-time AP Clerk to assist with the continued growth of the County and the increasing volume of financial transactions. While I plan to cross-train my existing staff to input invoices into the system, the ultimate oversight, review, and management of the AP process will rest entirely with me.

For context, the County Auditor's Office has one to two individuals available as backup for this function, whereas I will be solely accountable for ensuring its accuracy and timeliness if my AP clerk is out of the office. I am prepared to take on this increased responsibility, but I believe that my compensation should be adjusted accordingly to reflect the expanded scope of my duties.

Additionally, I would like to provide the Court with an update on the current revenue activity. The Treasurer's Office continues to be a highly productive department. With two months remaining in Fiscal Year 2024–2025, we are on track to exceed \$23–24 million in revenue. To date, our office has prepared and submitted over 1,205 individual revenue packets to the Auditor's Office for approval, not including other essential responsibilities we manage on a daily basis.
